On November 11<sup>th</sup>, I spent part of my day at the 16<sup>th</sup> Annual West Virginia Economic Outlook Conference. This was a great look into the business climate, labor market, and potential growth areas within the state. This conference is sponsored by the WVU College of Business and Economics and provides keen insight into the challenges and opportunities that are likely to be present in the upcoming year.

Discussed at the conference were several ways that WVU helps the state become more competitive. Research programs bring in between \$150 to \$200 million of external funds annually creating and improving many different segments of the economy. For each dollar that the state invests in WVU, the university returns \$20 back into the economy. Overall, WVU and its affiliates generate about \$4 Billion annually of economic impact into the state. In addition, the university will be exploring new partnerships with businesses that will prove beneficial to all involved.

There were several speakers that headlined the Veteran's Day Conference. One of them is David A. Wyss who is the

## WV Chamber Holds Chamber Networking Meeting

On November 12<sup>th</sup> and November 13<sup>th</sup> the WV Chamber held a two day event for chamber executives across the state. The mission of the meeting is to provide the chamber executives with the information and the resources to help us provide more to our members. The materials and discussions really helped to educate and inform the attendees on a wide range of state and federal issues.

On day 1 some of the topics that were covered were the Employee Free Choice Act, cap-and-trade, and health care reform. In addition considerable time was spent on policy recommendations for 2010, and the outlook for the 2010 Legislative Session. In fact, there will be a 2010 Legislative Outlook conference that I attend. If there are questions on issues that you want me to address with the WV Chamber, please be sure and email those to me. We finished up the afternoon with a conference call with the US Chamber to gain their perspective on the Consumer Financial Protection Act, and how to properly file and handle 990 tax forms for a chamber of commerce.

On Friday, we learned more on the challenges facing the coal

chief economist with Standard & Poor's. Overall, he feels that the recession is over and that the U.S. has hit the bottom. However, the recovery will be long and slow, and things are at a bottom which is when things will appear bleak. The housing market which has been a drag for three years appears to have stabilized, and our overseas trading partners are showing improvement which is helping with exports. He sees the financial system in a better state and that the stimulus packages have helped with consumer and government spending.

Even though there are some things that are better, there are several things that are still quite disconcerting. The private nonresidential construction continues to plunge. He was quick to point out that this is the longest and deepest recession since the 1930s. Although unlikely the recession could drag on if certain factors, such as drastically higher oil prices come into play. Dr. George W. Hammond, Ph.D. spoke specifically to the outlook for West Virginia in 2010. You can view his discussion on the WV economy by viewing Part 2 of the WV Economic Outlook Conference on <a href="https://www.youtube.com">www.youtube.com</a>. He provided substantial data on the trends in the labor market across the state. Data on home foreclosures, coal production, exports from the state, and other areas were provided. One thing that was discussed is the income gap for West Virginia when compared to other states. This gap will initially close, but will then stay about 15% to 20% below the national average. Another problem that we face in the state is that our population continues to age. In all age groups except the 65+ range, we are going to see decreases in the coming years.

Thus to sum it all up Dr. Hammond expects the WV labor market to stabilize in the first half of 2010 and to recover slowly in the second half of the year. In addition, it will take our state until 2013 to regain the lost jobs of the most recent recession. This is a substantially longer time period than the rest of the nation. The low unemployment levels of 2008 are not forecast to return anytime in the next 5 years, and the income of those in WV will lag that of the country for the foreseeable future.

## November Business Meeting: Perry Bryant with WVAHC Discusses Health Care Reform

On, November 19<sup>th</sup>, the lunch meeting of the Jackson County Chamber of Commerce was held at the Parchment

Valley Conference Center. I would like to thank Frank Miller and his staff for their hospitality, the wonderful food, and the facilities that were provided. Our topic covered in November was the one on the mind of virtually all Americans. This was the issue of health care reform.

I think that many would agree that there are some changes that need to be made, but how to fund and what changes need to be made are where the disagreements begin. Mr. Perry Bryant gave us his perspective as the Executive Director for West Virginians for Affordable Health Care of what may be to come if we have a universal health care system instituted in the country. I urge all of you to stay informed and to make individual contact with your representatives and let them know how you fell on this and any other issue. #### **Future Meetings Set for 2010**

Please mark your calendars for upcoming meetings of the JCCC. At noon on January 28, 2010 we will be meeting at Jackson General Hospital to learn more about the efforts of the Jackson County Anti-Drug Coalition and issues relating to a drug free workplace. Valuable information on how to get more involved with this groups work will be provided as well as how to handle drug issues in the workplace.

The February meeting will present another topic that many employers will want to take part. On February 25<sup>th</sup> at noon, Jennifer Burgess with OSHA will discuss the free on-site consultations that their agency offers. The program's goal is to improve the safety of the workers and to implement programs and procedures within your business that will adhere to OSHA guidelines. Because OSHA wants businesses to utilize this service, these consultations are confidential and without repercussions. In fact, it is possible to qualify for a one year exemption from routine OSHA inspections.

#### **Worthless Check Seminar**

On December 4th there was a worthless check seminar held at the Jackson County Courthouse which I was able to attend. Magistrate Tom Reynolds arranged for Caroline Stoker to host this event. Ms. Stoker is an expert when it comes to processing the paperwork and the legal nuances surrounding worthless checks. The county has highly trained staff to assist you in the process of collecting on worthless checks written to your business.
