shale expands throughout New York, Pennsylvania, Ohio, and West Virginia.

It has been the 2nd largest discovery of natural gas in the world. Scientists have estimated it to contain as much as 500 trillion cubic feet of natural gas. In North central WV the Marcellus Shale has been located between 6500-7500 feet below surface. With the new horizontal drilling they have advanced to, some drilling processes can cost between \$800,000-\$1.5 million and some economists have stated that by 2015 it will have created over 19,000 jobs.
